Branches of Government

- Legislature
 - Authority to make laws and to alter or repeal them.
- □ Executive
 - Authority to administer and enforce the laws.
- Judiciary
 - Authority to interpret and apply the law, adjudicate legal disputes.

Delaware Legislature

- □ Bicameral (Two houses)
 - Senate (21) Currently 12 D, 9 R
 - House (41) Currently 26 D, 15 R
- □ 150th General Assembly
- □ Legislative Leadership Who are they?
 - Majority/Minority Speaker, Pro Tem, Leader,
 Whip. Parlimentarians Speaker, Lt. Gov
 - Agriculture Committee Chairs/members
- □ Schedule

Legislation

- □ Bill
 - Amend Code
 - Appropriate funds
 - □ Amend local government charter
 - □ Direct someone to do something
- □ Joint Resolution
 - □ Direct someone to do something
 - □ Has effect of law, but only in effect during the General Assembly
- □ Resolution/Concurrent Resolution
 - □ Ask someone to do something
 - □ Statement or declaration
- Constitutional Amendment

Legislative process

- □ Each legislation must be heard three times in each house:
 - At introduction on floor or in Committee (Wednesdays)
 - Only venue for unsolicited public comment
 - Committee disposition reported on floor, placed on ready list
 - On floor for vote
- □ Legislation must be passed in each house *in the exact same form* before enactment
- □ Bills, Joint Resolutions require Governor's signature to be enacted

Laws

- □ Each Bill, Joint Resolution and Constitutional Amendment that is enacted creates a law
- □ Noted as volume and chapter
- □ Resolutions and Concurrent Resolutions do not have the power of law

Code

- Delaware Code is a compendium of most
 Delaware Laws
- □ 31 Titles including:
 - Business (Corporations, Insurance, Commerce and Trade, Banking, Property, Public Utilities, Professions and Occupations)
 - Judicial (Court Procedures, Criminal, Estates, Domestic Relations)
 - State Government (Transportation, Motor Vehicles, State Agencies, Taxes)
 - Local Government
